## **Useful information**

We kindly inform our clients about the following information which will be useful when making your reservation and for your stay :

1/ As soon as we receive your reservation form, we will send you a reservation form with figures, mentioning the amounts of the two deposits as well as the balance as follows

- The first deposit of 30% must be paid within 3 days.
- The second deposit of 30 % will be requested one month before the date of arrival.
- The balance is to be paid at the latest on the day of arrival.

Reservation in the following month: the first two deposits will be requested at the time of reservation.

Conditions of refunding of deposits: Only those mentioned in the GTC and beyond:

- The deposit is considered as acquired by the campsite and will not be refunded in any case if cancellation by the customer (and this whatever the personal reasons: illness, imperative reason, family reason, unavailability of the vehicle, hospitalization, severe weather, strikes, transport strikes etc...).
- We will not be able to refund the stay in case of early departure of the customer.
- In case of arrival later than the planned date of arrival, the customer will be asked to pay the full amount of his stay.
- If the client wishes to stay for a shorter period of time than that agreed upon at the time of reservation, the total amount of the stay will be the total amount of the stay will be requested.

2/ Our friends the animals are not allowed. It is forbidden to smoke inside the cottages.

3/ We ask our kind customers to deposit two deposit checks upon arrival: a check of 250.00 € for the deposit of the cottage and a check of 60.00 € for cleaning if it has not been done by the occupants at their departure from the site. These checks are not cashed and are returned on the day of departure of the customer if no damage is noted. The deposits can also be made by credit card (not debited and closed at the end of the stay).

4/ Arrival must be between 4:00 pm and 7:30 pm and departure between 8:30 am and 11:00 am. No entry can be made without prior registration at the reception and deposit of the deposit.

5/ Bed sheets and pillowcases are mandatory and not provided by the campsite. We kindly ask you to provide this equipment. Bath towels are not provided. The undersheets, pillows and comforters are provided.

6/ We inform our customers that our campsite is a place of peace and relaxation: we ask all our customers to respect the calm from 11:00 pm.

7/ Outside visitors not allowed in the campsite.
